### SPEAKERS PROFILE - PANEL I



**Dr. Shyam Sunder** is the James L. Frank Professor of Accounting, Economics, and Finance at the Yale School of Management; Professor in the Department of Economics; and Professor (Adjunct) at the Yale Law School. He is a world-renowned accounting theorist and experimental economist. His research contributions include financial reporting, dissemination of information in security markets, statistical theory of

valuation and design of electronic markets. He is a pioneer in the fields of experimental finance and experimental macroeconomics. Sunder has published six books and more than 150 articles in the leading journals of accounting, economics and finance, as well as in popular media. He is the immediate past president of the American Accounting Association and a winner of many research awards. Sunder's current research includes the problem of structuring US and international accounting and auditing institutions to obtain a judicious and efficient balance between regulatory oversight and market competition.



Padma Bhushan Dr. N.S. Ramaswamy, Founder Director — IIM-Bangalore, Director of NGO —CARTMAN. He has done his BSc. and BE degrees from Madras University. He underwent Postgraduate education in Glasgow, Lehigh and Stanford Universities as well as short term training in several institutions in US and Europe. He was actively involved in student movement, social service and public affairs, where he held elected

positions as Chairman, Secretary, such as, President of Students Association in Maharajas College at Kochi, Secretary of Students Association in the College of Engineering at Chennai, etc.



**Dr. Vidya Yeravdekar**, the Principal Director of Symbiosis Society is a gynaecologist, who also has a degree in law to add to her qualification. She has developed close contacts with the Ministries of Education in different countries. By liaison with these departments she is able to

understand the specific needs of the youth of those countries. Being a member of the Board of Management of the Symbiosis Society and Symbiosis Deemed University, she contributes to the overall planning and development of Symbiosis. She has been instrumental in collaborations of Symbiosis with some of the world-class universities. She is the member of the University Grants Commission and also member of governing body of International Council for Cultural Relations (ICCR), Govt. of India.







**Prof. Bala K. R. Balachandran** is a professor of accounting and operations management at New York University Stern School of Business. He teaches courses in management accounting, management control systems and financial accounting. Professor Balachandran has written and published more than 65 articles in leading academic journals of economics, accounting and management science. He is the editor-inchief of the *Journal of Accounting Auditing and Finance*. He is a member of the Asian American Advisory Council to the Governor's office in New

Jersey and a member of the International Advisory Board of the Indian Institute of Finance Business School in India. Professor Balachandran earned his Master of Science in industrial engineering, his Doctor of Philosophy in operations research and his certificate in management accounting from the University of California, Berkeley.



Mr. Dileep Ranjekar, Chief Executive Officer of Azim Premji Foundation, he is a science Graduate and has a Post Graduate Diploma of Business Management as well as Master's degree in Personnel Management and Industrial Relations from Tata Institute of Social Sciences, Mumbai. He was appointed from campus by Wipro and became the Corporate Executive Vice President Human Resources. The Foundation is focused on contributing to systemic changes such as building

accountability for quality education by demonstrating that comprehensive quality education can be achieved in rural Government schools.



**Prof. P.G Apte** was the professor of economics and former Director of Indian Institute of Management, Bangalore. He has been teaching optional courses on International Corporate Finance for a number of years. After his post graduation from IIM, Calcutta, he did his Ph D in Economics from Columbia University. Prof Apte speaks frequently on Currency Risk Management, International Capital Markets, Options and Futures, in workshops and seminars organized by companies and

professional bodies. He has authored two books and several papers in national and international journals.







**Dr. Pallab Bandyopadhyay** is Director–Human Resources at Citrix Systems. His former positions include Vice President, Human Resources, Dell Perot Systems and Chief People Officer, Cambridge Solutions Ltd. **Prof. Krishna Ladha**, Professor of Economics, IIM-Kozhikode, his research includes Law and Economics; Democracy; Stability and Constitution Design; Markets and Institutions; Information Aggregation in Committees; Social Choice; Political Philosophy and Business; and the Origin and Implementation of the Constitution of Ancient Athens. He has Ph. D. in Economics (Carnegie-Mellon University), PGDM from IIM

Calcutta, and M.Sc.in Mathematics from Calcutta University. He has taught in many top colleges across the world. He has also worked for the Planning and Analysis Group of the Department of Atomic Energy, Mumbai.
